

**Hawai'i Bowl Social Media Sweepstakes  
OFFICIAL RULES**

NO PURCHASE NECESSARY TO ENTER OR WIN A PRIZE.

A PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING.

**1. HOW TO ENTER:** In order to enter you must log onto Twitter, Facebook or Instagram (each a "Social Media Platform"), between **November 3, 2018** and **November 25, 2018** (the "Entry Period"). Entrant must **(i) visit the North Plaza Zone C-Gear Shop in Aloha Stadium to take a selfie with the 2018 Hawai'i Bowl trophy, (ii) post the selfie on a Social Media Platform and (iii) include @HawaiiBowl (on Twitter & Facebook) or @thehawaiibowl (on Instagram) PLUS #PlayedInHawaiiContest** (an "Entry"). In addition, Entrant will also have to "follow" or "like" the Hawai'i Bowl Social Media account and have your account set to receive a direct message from Sponsor. All Entries by entrants must comply with the applicable Social Media Platform's Terms of Service/Use. Limit one Entry per person. **This Sweepstakes is in no way sponsored, endorsed or administered by, or associated with, Twitter, Facebook or Instagram.**

**2. ELIGIBILITY:** The Sweepstakes is open to all legal residents of the United States ages 18 years and over as of the date of entry, unless prohibited in the state, who have an active Social Media Platform account. The following are not eligible for the Sweepstakes: (i) employees and agents of Sponsor, Presenter (if any), their respective parent, subsidiary and affiliated companies, and each of their respective advertising/promotion agencies, officers, members; and (ii) the "immediate family members" and/or "household members" of any of the persons set forth in (i) above. "Immediate family members" shall mean parents, step-parents, children, step-children, siblings or spouses. "Household members" shall mean people who share the same residence at least three (3) months a year. Void in all U.S. Territories (e.g., Puerto Rico and Guam) and wherever prohibited by law. Sweepstakes is governed by U.S. law and subject to all applicable federal, state and local laws and regulations. By entering the Sweepstakes, participants agree to accept and be bound by all terms of these Official Rules and Regulations ("**Official Rules**"). **3. PRIZE:** **One (1)** prize winner ("**Prize Winner**") will receive **four (4) tickets and one (1) parking pass to the 2018 Hawai'i Bowl on December 22, 2018 and the opportunity to be on the field for the trophy presentation** ("**Prize**"). Approximate retail value of the Prize is **\$188.00**. **PRIZE DOES NOT INCLUDE TRAVEL TO/FROM THE GAME.** Winner is responsible for all travel and other expenses related to attending the game. All state, federal, and local taxes or other expenses not specified herein are the sole responsibility of the winner. No prize substitutions or cash redemption will be made except in Sponsor's sole discretion.

**4. SELECTION OF WINNER:** The Prize Winner will be randomly selected by Sponsor from all eligible Entries received on all Social Media Platforms. The Prize Winner will be chosen on **November 26, 2018**. Sponsor will initially contact the Prize Winner via direct message on the Social Media Platform used to enter. In order to be chosen, potential winners must follow the @HawaiiBowl account on Twitter, @HawaiiBowl account on Facebook or @thehawaiibowl on Instagram. Once contacted, Prize Winner must provide their email address and telephone. Once selected, the Prize Winner will need to confirm their acceptance of the Prize via email or telephone prior to **December 7, 2018**.

Failure to timely confirm acceptance as set forth above, and/or the unavailability of any Prize Winner to be reached after a reasonable (as determined solely by Sponsor) effort has been made, may constitute

forfeiture of being a Prize Winner, at Sponsor's sole discretion, and a new Prize Winner may be selected from the remaining eligible entries. In addition, if the selected Prize Winner subsequently becomes unavailable to receive the Prize, he/she will be disqualified at Sponsor's sole discretion, and a new Prize Winner may be selected from the remaining eligible entries. Potential winners must continue to comply with all terms and conditions of these Official Rules, and winning is contingent upon fulfilling all requirements mentioned in these rules. Odds of winning depend upon the number of eligible entries received.

LIMITATIONS OF LIABILITY:** The Released Parties are not responsible for: (1) any incorrect or inaccurate information, whether caused by entrants, printing errors or by any of the equipment, hardware, software or programming associated or used with the Sweepstakes; (2) technical errors, defects, delays or failures of any kind, including without limitation malfunctions, interruptions or disconnections in communications lines, Internet or website access, hardware or software; (3) digital or electronic disruptions, e.g., viruses or other security breaches; (4) unauthorized human intervention, e.g., hacking; (5) technical or human error which may occur in connection with any aspect of the Sweepstakes; (6) any injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Sweepstakes, access to, copying or downloading materials from a Social Media Platform or any other website, or receipt or use of any prize.

**7. PRIVACY AND PUBLICITY:** All personally identifiable information submitted by participants in the Sweepstakes will be used to administer the Sweepstakes, select prize winners and fulfill prizes and will be treated according to the Privacy Policies available at [www.disneyprivacycenter.com](http://www.disneyprivacycenter.com). By submitting an Entry, entrant hereby grants permission for the Entry, including the entrant's Social Media Platform username or handle, to be posted on the Sponsor's website or other website for public view.

Except where prohibited, participation in the Sweepstakes constitutes participant's consent to the Sponsor use of his/her name (including username/handle for Social Media Platforms), likeness, voice, opinions, biographical information, and state of residence for promotional purposes in any and all media, in any manner, now or hereafter known throughout the world in perpetuity without further consideration or any payment.

**8. ADDITIONAL DISCLAIMERS:** If the Sweepstakes is not capable of running as planned for any reason, including, without limitation, because of a printing error, human error, unauthorized intervention, fraud, technical failure or other cause which corrupt or threaten to corrupt or adversely affect the administration, security, fairness, integrity or proper conduct of the Sweepstakes, Sponsor reserves the right, in its sole discretion, to cancel, modify or suspend the Sweepstakes, including awarding the Prizes from among eligible entries received prior to the time of the cancellation, modification or suspension. All participants, as a condition of entry, agree to abide by and be bound by these Official Rules and the decisions of Sponsor. Failure to comply with these Official Rules may result in disqualification from this Sweepstakes. Sponsor reserves the right to permanently disqualify any person it believes has violated these Official Rules. Participants further agree to not knowingly damage or cause interruption of the Sweepstakes. Any person who supplies false information, obtains entries by fraudulent means, or is otherwise determined to be in violation of these official rules in an attempt to obtain any prize will forfeit any prize won and may be prosecuted to the full extent of the law.
